It seems that we have been restricted to our homes for an eternity! But be advised I have good news!! We will begin training in the month of May for **all NYS Security Guard Courses**. Safety Quest is a certified NYS Security Guard School and, as such, is deemed an “Essential Business” under New York State Executive Order 202.2 (Quarantine). We will be able to conduct Armed Security Courses at the South Shore Shooting Range located at 130 Freeman Avenue, Islip, New York (just west of Route 111 off the North Service Road of the Sunrise Highway in Islip). We **will not** be able to conduct HR-218 Qualifications by themselves since it is not deemed as an “Essential Business.” We **are able** to conduct the HR-218 Qualification in conjunction with an Armed New York State Security Guard Course. We can certify you as an Armed Guard and give you the HR-218 Qualification as a Combo Course. These are the following dates in May:

- Wednesday, May 6<sup>th</sup>, 2020 start time 9:00 am – South Shore Shooting Range
- Wednesday, May 13<sup>th</sup>, 2020 start time 9:00 am - South Shore Shooting Range
- Wednesday, May 20<sup>th</sup>, 2020 start time 9:00 am - South Shore Shooting Range
- Wednesday, May 27<sup>th</sup>, 2020 start time 9:00 am - South Shore Shooting Range

We also will be teaching all the Unarmed New York State Security Guard Courses at the Belle Terre Community Center, located at 51 Cliff Road, Belle Terre (Belle Terre is the Village that sits next to Port Jefferson Village on the North Shore). These courses are as follows:

**Pre-Assignment Security Guard Course (unarmed Guard)**

- Monday, May 4<sup>th</sup>, 2020 and Tuesday May 5<sup>th</sup> 2020 starting at 6:00 pm classroom #2

**Annual In-Service Security Guard Course (Unarmed Guard)**

- Monday, May 4<sup>th</sup>, 2020 and Tuesday May 5<sup>th</sup> 2020 starting at 6:00 pm classroom #1

To protect your health and comply with Executive Order 202.2 we require that **you wear a mask** when attending any of our courses. All premises will be sanitized before you arrive.

**PAST ANNOUNCEMENT IMPORTANT INFORMATION DATED APRIL 1<sup>st</sup>, 2020**

**EXPIRED HR-218 QUALIFICATION:**

If you have an expired HR-218 Qualification Card and you also have a NYS pistol permit, it just means that you can not travel outside NYS at this time until you renew your qualification. You can travel in New York State using your valid pistol permit. For those of you that do not have a New York pistol permit and your HR-218 has expired, the safest thing to do is to put your weapons in the safe until we can complete a new HR-218 Qualification.

**EXPIRING OR EXPIRED NEW YORK STATE  
ARMED OR UNARMED SECURITY GUARD CARD:**

If your Security Guard card is expired (applies to guard cards that expired after 03/26/2020) or is expiring or about to expire, your license to operate as a NYS Security Guard will remain enforce for another 60 days or until May 27<sup>th</sup>, 2020. Go to this link:
